Consignor Agrees to the following:

1. **ALL ITEMS HAVE BEEN CHECKED FOR RECALLS and have NOT been deemed hazardous by the US Consumer Product Safety Commission.** All items have been checked on the CPSC website and are safe according to CPSC standards. Consignors are responsible for the safety of all items. BB's Closet does not assume responsibility or liability for the consignor's items. Consignor agrees to indemnify and hold BB's Closet harmless should any claims be filed resulting from recalled products.
2. All items must be clean (no stains, holes, etc.) and functioning (tested and no missing pieces). Battery-operated items should have batteries installed for the sale.
3. B.B.'s Closet reserves the right to reject any item, and may also remove an item from the sales floor at any time during the sale.
4. Consignor is responsible for tagging, pricing and hanging my own items and has followed the item limits specified on the BB's Closet website.
 - If Yes has been checked in answer to Reduce on your tag, the item WILL be discounted 50% OFF during the ½ price sale.
 - If Yes has been checked in answer to Donate on your tag, the item WILL be donated at the end of the sale.
 - If no price is indicated on a tag, then a price will be determined by B.B.'s Closet or the item will be pulled from the sales floor.
 - Items must have a minimum price of \$1.
5. Consignor accepts responsibility to pick up any unsold merchandise by the end of the designated pickup time; otherwise, the items become property of B.B.'s Closet and will be donated to charity "on the spot."
6. Although B.B.'s Closet will do its best to ensure that items are not damaged or stolen between drop-off and pick-up, B.B.'s Closet, the lessors of the space where the sale is held, and volunteers will not assume liability for the consignor's items. All sales are final and no returns, refunds or credits will be given.
7. Consignor agrees to waive any and all claims for personal injury resulting from participation in the sale, from whatever cause, against B.B.'s Closet, the lessors of the space where the sale is held, any volunteer or paid participant in the sale, and the insurer of B.B.'s Closet.
8. If a self-addressed stamped envelope is not provided at drop-off, \$1.00 will be deducted for postage and/or envelope.
9. Consignor understands that a non-refundable \$12.00 registration fee will be collected at check in of items.
10. Consignor understands that proceeds will be 60% of selling prices; 70% if volunteering 4 hours during the sale or fulfilling a bartering agreement; and/or 75% for volunteering for 8 or more hours during the sale.
11. **ALL EARNINGS CHECKS SENT TO THE CONSIGNOR MUST BE CASHED WITHIN 60 DAYS OF CHECK DATE OR CHECK WILL BE CANCELLED! NO EXCEPTIONS!**
